| <b>FIRST AID:</b> | <b>Swallowed:</b> If swallowed do NOT induce vomiting. For advice, contact the National Poisons Centre on 0800 POISON (0800 764766) or a doctor immediately. Take to hospital without delay.  |
|                   | <b>Eyes:</b> If concentrate is splashed in eyes, flush with running water for at least 15 minutes. Take to hospital without delay.  |
|                   | <b>Skin:</b> If spilt on skin, remove contaminated clothing and wash affected areas of skin. DO NOT SCRUB THE SKIN.   |
|                   | <b>Inhaled:</b> Remove to fresh air.  |
| <b>FIRE:</b>      | Extinguishing media: Water, Foam, Carbon dioxide, Dry chemical. Use extinguishing media appropriate for surrounding fire. High temperature may release toxic gases, Carbon dioxide, Carbon monoxide, Nitrogen oxides. Do not enter fire area without proper protective equipment, including respiratory protection.   |
| <b>SPILLAGE:</b>  | Wear protective equipment to prevent skin and eye contamination and inhalation of vapors. Contain and prevent contamination of drains and waterways. Use absorbent, soil, vermiculite, attapulgit bentonite or clay absorbent. Collect and seal in plastic lined drums for disposal in an authorised landfill. Wash the spill zone down with excess water avoiding contamination of any water body. |
| <b>DISPOSAL:</b>  | Triple rinse container and add residue to spray tank. Burn, if circumstances, especially wind direction permit, otherwise bury in landfill.   |
