<b>FIRST AID:</b>	<b>Swallowed:</b> If swallowed do NOT induce vomiting. For advice, contact the National Poisons Centre on 0800 POISON (0800 764766) or a doctor immediately.
	<b>Eyes:</b> If product or spray enters eyes, wash out immediately and continue rinsing with clean water for at least 15 minutes. Obtain medical attention.
	<b>Skin:</b> After contact with skin, wash immediately with soap and water.
	<b>Inhaled:</b> Remove to fresh air.
<b>FIRE:</b>	<b>Extinguishing media:</b> Foam, carbon dioxide, dry chemicals, and water spray.
<b>SPILLAGE:</b>	Wear appropriate protective clothing and prevent material from entering waterways. Absorb spills with inert material and place in waste containers. Wash area with water and absorb with further inert material. Dispose of waste safely (such as to a suitable landfill).
