EMERGENCY MANAGEMENT

FIRST AID:	Swallowed: If swallowed do NOT induce vomiting. For advice, contact the National Poisons Centre on 0800 POISON (0800 764766) or a doctor immediately.
	Eyes: If product or spray enters eyes, wash out immediately and continue rinsing with clean water for at least 15 minutes. Obtain medical attention.
	Skin: If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water.
	Inhaled: Remove to fresh air.
FIRE:	Extinguishing media - SMALL FIRE: Use DRY chemical powder. LARGE FIRE: Use water spray, fog or foam. Do not use water jet. Fire fighters should wear positive pressure self-contained breathing apparatus (SCBA) and full turnout gear.
SPILLAGE:	Wear protective equipment to prevent skin and eye contamination and inhalation of vapors. Contain and prevent contamination of drains and waterways. Use absorbent, soil, vermiculite, attapulgate bentonite or clay absorbent. Collect and seal in plastic lined drums for disposal in an authorised landfill. Wash the spill zone down with excess water avoiding contamination of any water body.
DISPOSAL:	Triple rinse container and add residue to spray tank. Burn, if circumstances, especially wind direction permit, otherwise bury in landfill.
