EMERGENCY MANAGEMENT

FIRST AID:	<p>Swallowed: Rinse mouth. DO NOT INDUCE VOMITING. Obtain emergency medical attention.</p> <p>Eyes: In case of eye contact, immediately rinse with clean water for 10-15 minutes. Obtain emergency medical attention if pain, blinking, tears or redness persist.</p> <p>Skin: For even minor contact, immediately remove contaminated clothing/wash skin thoroughly with mild soap / water.</p> <p>Inhaled: Assure fresh air breathing. If breathing is difficult, give oxygen. If not breathing, give artificial respiration. Obtain medical attention if breathing difficulty persists.</p>
FIRE:	Minimise generation of dust. No naked lights. No smoking. Use water, foam, carbon dioxide, or dry chemical to extinguish fire. When heated to decomposition, emits dangerous fumes. Do not enter fire area without proper protective equipment, including respiratory protection.
SPILLAGE:	Collect and seal in plastic lined drums for disposal in an authorised landfill. Wash the spill zone down with excess water avoiding contamination of any water body.
DISPOSAL:	Dispose of empty packaging safely. Burn, if circumstances, especially wind direction permit, otherwise bury in landfill.
