EMERGENCY MANAGEMENT

FIRST AID:	Swallowed: If swallowed do NOT induce vomiting. For advice, contact the National Poisons Centre on 0800 POISON (0800 764766) or a doctor immediately.
	Eyes: If product or spray enters eyes, wash out immediately and continue rinsing with clean water for at least 15 minutes. Obtain medical attention.

FIRE:	Extinguishing media: Alcohol-resistant foam, carbon dioxide, dry chemicals, and water spray.
