## EMERGENCY MANAGEMENT

<b>FIRST AID:</b>	<b>Swallowed:</b> If swallowed do NOT induce vomiting. For advice, contact the National Poisons Centre on 0800 POISON (0800 764766) or a doctor immediately.
	<b>Eyes:</b> If product or spray enters eyes, wash out immediately and continue rinsing with clean water for at least 15 minutes. Obtain medical attention.
	<b>Skin:</b> After contact with skin or hair, wash immediately with soap and water.
	<b>Inhaled:</b> Remove to fresh air.
<b>FIRE:</b>	Extinguishing media - SMALL FIRE: Use DRY chemical powder; LARGE FIRE: Use water spray, fog or foam. Do not use water jet. Fire fighters should wear positive pressure self-contained breathing apparatus (SCBA) and full turnout gear.
<b>SPILLAGE:</b>	Wear appropriate protective clothing and prevent material from entering waterways. Absorb spills with inert material and place in waste containers. Wash area with water and absorb with further inert material. Dispose of waste safely (such as to a suitable landfill).
<b>DISPOSAL:</b>	Triple rinse container and add residue to spray tank. Dispose of empty container safely. Burn, if circumstances, especially wind direction permit, otherwise bury in landfill. Avoid contamination of any water supply with chemical or empty container.
