FIRST AID:	<p>Swallowed: If swallowed do NOT induce vomiting. For advice, contact the National Poisons Centre on 0800 POISON (0800 764766) or a doctor immediately.</p> <p>Eyes: Rinse opened eye for several minutes under running water. If symptoms persist, consult doctor.</p> <p>Skin: If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water.</p> <p>Inhaled: Remove to fresh air.</p>
FIRE:	Extinguish fires with CO ₂ , extinguishing powder or water fog. Fight larger fires with water fog or alcohol-resistant foam. Formation of toxic and corrosive gases during heating or in case of fire - Sulfur oxides (SOx). Wear self-contained breathing apparatus. Wear full protective suit.
SPILLAGE:	Wear appropriate protective clothing and prevent material from entering waterways. Absorb spills with inert material and place in waste containers. Wash area with water and absorb with further inert material. Dispose of waste safely (such as to a suitable landfill).
DISPOSAL:	Dispose of empty packaging safely. Burn, if circumstances, especially wind direction permit, otherwise bury in landfill. Avoid contamination of any water supply with chemical or empty packaging.
