## EMERGENCY MANAGEMENT

<b>FIRST AID:</b>	<b>Swallowed:</b> If swallowed do NOT induce vomiting. For advice, contact the National Poisons Centre on 0800 POISON (0800 764766) or a doctor immediately.
	<b>Eyes:</b> If product or spray enters eyes, wash out immediately and continue rinsing with clean water for at least 15 minutes. Obtain medical attention.
	<b>Skin:</b> If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water.
	<b>Inhaled:</b> Remove to fresh air.
<b>FIRE:</b>	Make use of fine water spray, foam, dry chemical, or carbon dioxide to extinguish fires. DO NOT use a direct jet of water.
<b>SPILLAGE:</b>	Wear protective equipment to prevent skin and eye contamination and inhalation of vapors. Contain and prevent contamination of drains and waterways. Use absorbent, soil, vermiculite, attapulgite bentonite or clay absorbent. Collect and seal in plastic lined drums for disposal in an authorised landfill. Wash the spill zone down with excess water avoiding contamination of any water body.
<b>DISPOSAL:</b>	When emptying container, triple rinse and add remaining material to spray tank. Return the empty container to an AgRecovery collection point for disposal.
