EMERGENCY MANAGEMENT

FIRST AID:	Swallowed: If swallowed do NOT induce vomiting. For advice, contact the National Poisons Centre on 0800 POISON (0800 764766) or a doctor immediately.
	Eyes: If concentrate is splashed in eyes flush with running water for at least 15 minutes. Take to hospital without delay.
	Skin: If spilled on the skin, remove contaminated clothing and wash affected areas of skin. DO NOT SCRUB THE SKIN.
	Inhaled: If inhaled, remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical attention.
FIRE:	To extinguish – SMALL FIRE: Use DRY chemical powder. LARGE FIRE: Use water spray, fog or foam. Do not use water jet.
SPILLAGE:	Wear protective equipment to prevent skin and eye contamination and inhalation of vapors. Contain and prevent contamination of drains and waterways. Use absorbent, soil, vermiculite, attapulgit bentonite or clay absorbent. Collect and seal in plastic lined drums for disposal in an authorised landfill. Wash the spill zone down with excess water avoiding contamination of any water body.
DISPOSAL:	Triple rinse empty container and add rinsate to spray tank. Burn in an appropriate incinerator, if circumstances such as wind direction permit. Otherwise crush and bury in a suitable landfill. Avoid contamination of any water supply with product or empty container.
